

{Gas South, LLC Referral Partner Program Terms}

The following are the general terms and conditions (“Terms”) which apply to Gas South’s Referral Partner Program (“Campaign”). Gas South, LLC (“Gas South” or “Advertiser”) is a certificated natural gas marketer. The Campaign is composed of 3 separate programs (each a “Program”): (1) “Gas South’s Real Estate Partner Program” in which licensed realtors only are eligible to participate, (2) “Gas South’s Leasing Partner Rewards” in which real estate leasing agents only are eligible to participate, and (3) “Gas South refer-a-friend” in which current customers with an active Gas South residential account only are eligible to participate (licensed realtor, leasing agent, current customer each a “Partner” within their individual Program). The purpose of the Campaign is for a licensed realtor to refer a purchaser of real estate, a leasing agent to refer a lessee, or a current Gas South customer to refer a prospective Gas South customer (each a “Prospect”) to Gas South for the Prospect’s new natural gas service at an address (“Location”). Participation in the Campaign is agreed by the Partner to be acceptance of these Terms.

Gas South will pay Partner a one-time referral fee (“Commission”) for each Prospect referred by Partner within Partner’s Program who selects Gas South as its natural gas provider at Prospect’s Location, who Gas South approves as its customer (“Customer”), and who continuously maintains and timely pays for natural gas service for a minimum of ninety (90) days from initiation (“Approved Transaction”), provided Partner, is registered on the Performance Horizon Group Ltd. (“Partnerize”) Management Platform (“Platform”) and Customer utilizes the personal URL provided by Partner for Customer to initiate natural gas service at the Location. Partner will be paid the Commission through either PayPal, Inc. or ACH deposit initiated by Partnerize. Only one Commission will be paid per Customer Location/Gas South account number.

Partner must accept, and will be subject to, Partnerize Partner Terms and Conditions for participation on the Platform owned and operated by Partnerize, as well as the terms of use of PayPal, Inc. or any banking institution utilized for ACH deposit. Partner acknowledges Partnerize, PayPal, Inc., and banking institutions (“Service Providers”) are independent contractors, and are not partners, joint venturers, employees, or agents of Gas South, and Partner agrees Gas South is not responsible for the acts or omissions of the Service Providers.

The Campaign is available only in those states in which Gas South is a certificated natural gas marketer. It is expressly agreed and understood that Partner is an independent contractor, not a partner, joint venturer, employee, or agent of Gas South, and Partner agrees Gas South is not responsible for the acts or omissions of the Partner. Partner has no authority to act for or on behalf of Gas South or to bind Gas South to any customer contract with a Prospect and Gas South retains exclusive authority to determine whether to accept a Prospect as a Customer. This Campaign replaces any previous Gas South referral incentive programs with any real estate leasing agents, licensed realtors, or Gas South customers, and terminates any referral agreements previously entered. Gas South reserves the right to modify the Terms of, limit, restrict participation in, or terminate the Campaign, or remove Partner from the Campaign at any time for any reason and without notice. The laws of the state of Georgia govern these Terms and Campaign, and the exclusive jurisdiction and venue for any disputes shall be Cobb County, Georgia.
